MOSES Lobby Day a Success; Members Urged to Keep up the Pressure

President Joe Dorant explains, "More than 100 members took time off to attend and stand in solidarity against the devastation House Bill 59 would have on upwards of 60% of our membership." MOSES' solid advocacy, testimony and presence definitely captured the attention of the members of the Public Service Committee. So much so, Chairman Aaron Michlewitz and Committee Member Sen. Dan Wolfe specifically noted the impressive showing made by MOSES advocates.

MOSES members, correctional officers, social workers and higher education teachers spoke movingly about how H.59 will wreak havoc on their financial health, and in some cases their physical health. We are hopeful that the Public Service Committee will recognize H.59 for what it is: a broken promise to thousands of state employees.

Dear MOSES member,

First, Happy New Year!!! This is the beginning of what I hope is a good year for MOSES represented employees and their families.

Last year at this time, Governor Patrick caused quite an uproar on Beacon Hill and with thousands of state employees when he filed House Bill No. 59. The bill, if signed into law, would force state employees to work longer for a reduced health insurance benefit, resulting in great financial hardship for 60% of our membership. We educated you on the bill and asked you to take action. Many of you called and wrote emails to your legislators, delaying action on the bill. Then, at the end of October, the Public Service Committee held a public hearing on the bill and we asked again for your help. The MOSES staff and Board of Directors organized a hugely successful "Lobby Day," that drew over 100 of our members to Beacon Hill to attend the hearing and lobby their legislators on the adverse effects the bill would have on their families. Again MOSES members responded! I was so proud of what we had accomplished. That is the way that you make an impact on Beacon Hill. While the bill has not been released from the committee, we expect there will be some action on this issue in the future. We must continue our efforts to oppose this bill. So we ask again, please keep up your calls and emails to your elected officials!

Also, last year, our lobbying efforts paid off during the budget process. MOSES was successful in restoring funds in many of our agencies that had seen deep cuts in their programs due to the recession. We were also effective in advancing our OSHA protection bill through the legislative process. This will be a major effort during the remainder of this legislative session.

While much was done last year, there are still challenges for us to confront for this year. MOSES has three separate contract negotiations going on simultaneously (MassDOT, MWRA and the Commonwealth). The chairmen and the committees have been very busy incorporating your ideas into new proposals that will be brought forward during the discussions. At MassDOT, we continue to work on the classification study and vacation buyback. At other agencies we have unique issues to resolve and we will continue to participate in Labor/ Management meetings in attempts to settle problems and concerns before they become grievances.

Recently I have appointed Travis Hinton from DCAMM and Will Morin from MassDOT (D-2) to vacant MOSES Board of Directors seats and I also appointed Mary Richmond from DCAMM as a steward. These folks have stepped up to help run the organization and I am very appreciative of their time and efforts. I will be making more appointments in the future as the board has vacant seats in public health and impending vacant seats at other agencies. Folks who are willing to serve should contact either me or B. Marie Cunningham in the MOSES office.

With several members of the legislature leaving, there will be many special elections in the coming months. I urge you to support candidates that understand the efforts of public employees. The MOSES legislative committee at the last board of directors meeting chose to endorse Representative Christopher Fallon from Malden for the Fifth Middlesex Senate seat. Chris has been a strong supporter of MOSES throughout his tenure as a state representative and has earned our endorsement. He has sponsored many of MOSES legislative proposals over the years. I ask all of the 145 members in the senate district to support Chris and help to get him elected. (If you wish to participate in his campaign please contact Bridget Quinn in the MOSES office.)

Many members attended one or more of the annual holiday parties sponsored by MOSES and feedback was mostly positive. Of course the best attended party was the luncheon in Charlestown where over 350 members packed the Knights of Columbus Hall. Thanks to the board members who arranged and managed these galas and of course to Janet from the MOSES office for her outstanding support and organizational skills!

I hope to see you at the next membership meeting at Ken's Steakhouse in Framingham.

Increased H&W Benefits, Death Benefit, and More

When making out your dental/optical reimbursement form you will notice several improvements and changes over last year. Some of the changes include: an increase to the reimbursement amount on the open plan; limited reimbursement for laser surgery; the decreased waiting time from 6 months to 2 months for new employees; a \$5000 death benefit; a 1+1 plan from Altus; and an extension of COBRA benefits for 5 years for retirees. All dental work done or all optical purchases made on or before 12/31/13 should be submitted as a 2013 expense regardless that the bill was not paid until 2014. If you don't submit these 2013 expenses before June 30, 2014, you **cannot** get reimbursed for them on your 2014 claim. If you become aware of any employee or retiree who dies during 2014, please contact Paul Donohue at (617) 367-2727 x 317.

Last year, two MOSES members died a few months after retiring. If any MOSES member knows that death is imminent, it is almost always best to remain on the payroll by using the Mutual Aid provision under Article 13A.5 of the Collective Bargaining Agreement or the Employee Illness Leave Bank which provides up to 120 days paid leave. Even if you have to go off the payroll for a short period of time by using the Medical Leave provided under Article 8.7B of the Collective Bargaining Agreement this should be considered particularly if you are married. The reason is that under Option D, survivors receive a pension at least 50% higher when a person dies while employed rather than retired. If you are not married, you must choose an Option D beneficiary before you die because failure to do so prevents a survivor from receiving a pension and the only option is a return of your contributions. I am available to discuss with any MOSES represented employee retirement issues for those considering retirement. Everyone knows birthdays are important for people under 65 but sometimes a few days more or less can change your retirement amount by up to 1%. Call me or email me with your questions.
