

## M.O.S.E.S. BOARD OF DIRECTORS MEETING Tuesday, June 13, 2023

The Colonial Inn, Concord and remote via Zoom video conferencing

President Russell called the meeting to order at 10:20 a.m. This is the 39th board meeting using video conferencing and a hybrid in-person/remote meeting format.

President Russell appointed Mr. Prendergast as Sergeant at arms and MOSES Attorney Catherine Costanzo as Parliamentarian.

The Board of Directors meeting minutes from the May 09, 2023 meeting were read. MOTION by **Manual State Stat** 

The General Membership meeting minutes from the May 09, 2023 meeting were read.

The correspondence to and from MOSES was read.

The Treasurer's report for May 2023 was presented by Treasurer Leger. MOTION by to accept the Treasurer's report that PASSED.

President Russell gave his administrative report. The topics included

- Training Trust issues in the Commonwealth contract

MOTION by to go into executive session for purposes of discussing personnel matters and employee health care that PASSED. Ms. Costanzo left the meeting.

The Board went into Executive session from 1:47 to 3:19 pm. The public outcome from the executive session is as follows;

MOTION 1 (20230613-E1) to rescind MOTION (200904-8) by

passed as Amended at the BOD Meeting on 4/14/2009. That Motion from 2009 reads as follows: to continue the 8 MOSES employees present health insurance benefits as provided by "HMO Blue Value Plus" plan by enrolling them in the lower cost "HMO Blue with coinsurance" plan and timely reimbursing the employees for additional co-payments incurred. With the Amendment by Mr. Smigliani / Mr. Galvin that all reimbursements be submitted to the Treasurer and be reimbursed by check.

MOTION (20230613-E2) to hire a Legislative Assistant with a salary of between of \$80,000 - \$100,000 at the discretion of the President. Funds to come from the Administration account. MOTION PASSED UNANIMOUSLY

MOTION (20230613-1) by that the funding for the \$1,500 in reimbursable expenses for Mary Richards to attend the 2023 NASHTU conference as approved at the May Board of Directors meeting is to come from unencumbered funds." MOTION PASSED

MOTION (20230613-2) by to accept the President's recommendation and appoint Wilfred Mbah as a MOSES steward for the Department of Environmental Protection (DEP). MOTION PASSED UNANIMOUSLY

MOTION (20230613-3) by to accept the President's recommendation and appoint Jennifer Montgomery as a MOSES steward for State Police (DSP) MOTION PASSED UNANIMOUSLY

MOTION (20230613-4) by to make Karen Farris a lifetime MOSES member upon her retirement in recognition of her hard work and service as a MOSES Director.

MOTION PASSED UNANIMOUSLY. Ms. Farris abstained.

MOTION (20230613-5) by *MOTION* (202005-2) by *to transfer \$7,000 from unencumbered funds to set up a COVID-19 relief fund to be overseen by the goodwill committee for the purpose of assisting members in need and affected by COVID-19, that passed unanimously at the BOD meeting on 5/12/2020 and to release the money from unencumbered funds back into the MOSES cash accounts.* 

MOTION PASSED UNANIMOUSLY
