MOTION to change the MOSES Safe harbor 401K contributions amount from a 3% matching contribution as approved at the November 10^{th} , 2024 Executive session to a 100% match on the first 3% and 50% match on the next 1% for a maximum contribution of 3.5% in order to conform to IRS regulations.
